All entries are subject to the priority system; anglers will be notified upon receipt of their entry form and fee.

The entry fee includes tournament fishing boats, line, hooks, bait, lunches, crew's tips, angler and spouse/guest admission to activities, pre-tournament, dockside and awards parties.
