Due to the unique combination of anglers per boat, fish days and draw, angler positions will be released and filled by increments of 6 after the initial 30 angler reservations are filled. All entries are subject to the priority system; anglers will be notified upon receipt of their entry form and fee. (You are welcome to add your 2025 Club Dues which are \$150.00)
